### **Develop a common challenge-based framework for education**

- Addressing social challenges are making the traditional, one-off, discipline-based degrees obsolete.
- In a world in which tomorrow's jobs have not yet been invented, students need lifelong learning, competency-based, challengeoriented international programmes.
- They need to be able to personalise their education, choosing what to study and when, combining full degrees with micro-credentials.



## **Key consideration**

- A Standardized EU-Approach : collaboration accross borders and portability
- A Common Understanding :
  - 1 and 15 ECTS in volume, institutionnal decision making
  - Transdisciplinary
  - Alignement between learning outcomes (challenged based as much as possible)
  - Target groups : LMD
  - Digital portability

### **Key consideration**

### Design & Issuance of Micro Credentials

- Transparency: In regard to credit load, the Alliance will use ECTS. Micro- credentials may be included in national qualification frameworks/systems
- Relevance: 4EU+ micro- credentials will respond to the needs and challenges of society and aim to be interdisciplinary and foster transversal and transferrable skills.



### **WP2: Identify skills and needs**

- Identifying the reskilling and upskilling needs of specific demographics (learners on e.g. bachelor or more advanced level).
- Analysing and mapping of the identified needs to explicitly highlighting skill gaps
- Pinpointing different demographics' (learners) needs in terms of educational approaches
- Creating a flexible needs model

Industry partners will be brought by the three Chambers of Commerce, the Assolombarda confindustria di Milano, the City of Warsaw, the Metropolregion Rhein-Neckar GmbH, the social partners (GIM-Paris IIe de France) and companies like SUEZ, Essilor Luxottica, KPMG, SAP and BioRN.

# WP3: Design micro credential approach starting with existing learning pathways

- Building a comprehensive catalogue of the 4EU+ Alliance learning modules capable of meeting the reskilling and upskilling needs assessed in WP2
- Defining the 4EU+ Approach for MCs on green and digital competencies and skills, by (i) piloting the methodology already applied for the purpose of the 4EU+ curriculum on Entrepreneurship
- Activating the 4EU+ pedagogical framework and cooperative schemes
- Enabling graduates and undergraduates to make autonomous and informed choices about how to meet their own upskilling and reskilling needs

### WP4: Improve micro credentials pilot approach

- Generate the groundwork for integrating micro-credentials into the existing quality management system of the 4EU+Alliance, 4EU+QUALITY
- Document and analyse quality assurance systems at all individual member institutions about existing approaches on micro-credentials
- Examine and analyse existing approaches and recommendations on quality management of micro-credentials to align with European and international standards.

Public Authorities (e.g., Ministry of Education forms Czech Republic, Evaluation Agency like Hcéres in France and accreditation agency in Poland) and the President of the "Comité de suivi LMD" of the French Ministry of Higher Education, will provide guidance on the regulatory frameworks and standards that the micro credentials must adhere to.




